QDRO Pros, Inc., as a neutral party, cannot advise you on which method of division to use.

	SEGREGATION METHOD	TIME RULE FORMULA
Availability	Only available if Member has not yet retired or begun to receive a benefit of any kind.	Available if Member is active or retired.
Award Calculation	The amount awarded to Nonmember Spouse is typically 50% of Member's service credit years, contributions and interest earned from the date of marriage to date of separation. Nonmember Spouse can then apply for a lump-sum distribution at any time, or at age 55 or older receive a lifetime monthly benefit. Nonmember Spouse's monthly benefit is calculated using Member's salary on date of separation, Nonmember Spouse's age at the date of retirement and the service credit awarded to Nonmember Spouse.	CalSTRS calculates the service credit earned by Member from date of marriage to date of separation and determines what ratio of Member's monthly benefit is community property and what percentage of Member's benefit is payable to Nonmember Spouse each month. Nonmember Spouse's benefit is calculated using Member's salary at the time of retirement.
Restrictions	Member's Defined Benefit Supplement account or Cash Balance Benefit account can only be divided using the segregation formula. This is because only contributions and interest are earned but not service credit.	None
Availability of Nonmember Spouse's Share	Immediately available – Nonmember Spouse receives a separate account or a monthly benefit when Nonmember Spouse is age 55.	Not available until Member retires – Nonmember Spouse does not receive a separate account.
Impact of Service Credit & Contributions	Service credit is removed from the member's account.	Service credit is not removed from the member's account.
